



Forbes Australia (Success Publishing Pty Ltd) – Zwift Ride Giveaway

Terms and Conditions

Introduction

By entering the Forbes Australia Zwift Ride Giveaway (Competition), entrants agree to be bound by these terms and conditions. Any reference to “We”, “Us” or the “Promoter” is a reference to Forbes Australia, published by Success Publishing Pty Ltd.

Duration

Entries open at 12:01am AEDT on 18 December 2025 and close at 11:59pm AEDT on 15 January 2026. The Promoter reserves the right to extend the Competition period at its discretion.

Eligibility

Entry is open to permanent residents of Australia aged 18 years or over.

Method of Entry

To enter, entrants must:

- Follow Forbes Australia on Instagram at the time of entry and at the time the winner is drawn; and
- Submit an entry via the online form, answering in 25 words or less:

“What is your biggest health and wellness goal for 2026?”

Incomplete, indecipherable or invalid entries will be deemed ineligible. The Promoter may disqualify any entry that contains unlawful, offensive, defamatory, or inappropriate content, or content that may damage the Promoter's reputation.

Entrants may submit one entry only. Multiple entries, entries submitted using multiple identities, or entries submitted on behalf of another person will result in disqualification. The Promoter may enforce this clause even after a prize has been awarded.

It is the entrant's responsibility to ensure contact details are accurate and up to date.

Judging

One (1) winner will be selected. All decisions are final and no correspondence will be entered into.

The Zwift Annual Membership includes a 12-month subscription valued at A\$299.99. Total prize value is A\$2,599.94 based on recommended retail prices at the time of publishing.
