TERMS & CONDITIONS OF ENTRY

13 January 2026

PROMOTION PERIOD

The Forbes Women in partnership with Women Unlimited Leadership Summit “Lunch with Kamala Harris” Promotion (the “Promotion”) begins at [12 January 2026, 9:00 AM AEDT] and ends at 11:59 p.m. AEDT on 31 January 2026 (the “Promotion Period”).

ELIGIBILITY

The Promotion is open to individuals who are 18 years of age or older at the time of entry, are Australian residents, and hold an active, paid Forbes Women membership (each an “Entrant”).

This includes:

- Current Forbes Women members with an active, paid membership; and
- Individuals who join or renew a Forbes Women membership during the Promotion Period, once payment has been successfully completed.

Entries submitted prior to confirmation of an active, paid Forbes Women membership will not be eligible.

Employees of Success Publishing Pty Ltd trading as Forbes Australia (the “Sponsor”), its related bodies corporate, affiliates, agencies, contractors, and their immediate family members or household members are not eligible to enter.

HOW TO ENTER

During the Promotion Period, Entrants may receive one (1) entry by joining or renewing an eligible Forbes Women membership via the Forbes Australia website during the Promotion Period.

As part of the entry process, Entrants must submit a written response of 25 words or fewer answering the following question:

“Tell us in 25 words or less the one question you would ask Kamala Harris if you win.”

Limit one (1) entry per person. Automated, bulk, scripted, or mechanically reproduced entries are void.

JUDGING

This Promotion is a game of skill. Chance plays no part in determining the winners.

All eligible entries will be judged by the Forbes Australia Editorial team based on skill, including originality, relevance, clarity, and quality of response.

Judging will take place on Monday, 2 February 2026.

The five (5) best entries will be selected. The judges’ decisions are final and no correspondence will be entered into.

PRIZE

Prize Description

There are five (5) prizes to be won.

Each prize consists of:

- Two (2) VIP tickets (winner plus one guest) to the Women Unlimited Leadership Summit 19 & 20 February, Sydney.

- Lunch with Kamala Harris
- A photo opportunity with Kamala Harris

Each prize allows the winner to attend the event with one (1) guest.

If a winner does not respond within the timeframe specified by the Sponsor, the Sponsor reserves the right to award the prize to the next best eligible entry.

The winners' names may be published on the Sponsor's website and social media channels.

The Sponsor will not be liable for any delay, interruption, or failure to perform its obligations under these Official Rules where such delay or failure results from events beyond its reasonable control, including but not limited to acts of God, natural disasters, war, terrorism, civil unrest, pandemics, public health emergencies, government restrictions, security requirements, venue unavailability, or technical failures ("Force Majeure Event").

In the event of a Force Majeure Event, the Sponsor reserves the right to modify, reschedule, substitute, or cancel the Promotion or prize (or any part thereof), subject to applicable law.
